#### I. Lunch, welcome, and introductions

The meeting began at **11:45** AM with Dr. Alfaro welcoming the DEAC Committee. Guests performed brief introductions before reviewing their roles and responsibilities.

# II. Overview of Roles & Responsibilities

The DEAC has combined the councils and duties of the district SBDM committee, School Health Advisory Council (SHAC), and the district Technology Committee. The DEAC serves as the district site based decision making team. Members of the team were encouraged to communicate regularly with those groups they represent on the committee. Additionally, the work of subcommittees was discussed with the members as a way of being efficient with the workload of this team.

#### III. Business & Planning

#### A. DEAC Calendar Subcommittee

This sub-committee will be responsible for reviewing the 2020-201 calendar presented later in the Fall to the Board of Trustees. The committee will convene on October 14th from 4:30-5:30 PM at Central Office. Dr. Alfaro called for members to sign-up to participate.

# B. Bond Update

# C. HS Commons Update

Richard Mallard, Senior Area Foodservice Director, provided an update on the new AH Commons. Mr. Mallard showed before and after pictures of the Oaks Café and the Mule Stall. The Oaks Cafe features 4 stations: pizza/pasta, a grill line, the daily special, and the salad/deli line. The Mule Stall is a coffee and smoothie bar. He reported that usage is up tremendously, and the cafeteria is full every day during lunch.

# D. Legislative Updates

Dr. Alfaro updated the committee about Senate Bill 11 (SB11). This bill identifies school safety items and meetings schools must incorporate. Under SB11, Dr. Alfaro will be adding additional District Safety Committee Meetings and increasing membership to include administrators, board members, teachers, and parents.

In 2019-20, AHISD will embark on a Strategic Action Process that will help us to map out our next five years of priorities to fulfill our mission as a district and our vision for students, embodied in the AHISD Profile of a Learner.
