### **II. Business and Planning**

#### **A. Overview of COVID Information for 2021-2022: Dr. Frank Alfaro**

Dr. Alfaro shared COVID data from the [AHISD COVID data webpage](#) which has been up all school year. He gave a brief explanation of the data and how to read the information per campus, which is updated weekly after 3pm on Monday. Dr. Alfaro reviewed the Fall and Spring data collected this 2021-2022 school year and compared the information to the 2020-2021 school year to illustrate the impact that the COVID omicron variant surge had on student and staff absences, as well as substitute teachers. He also shared that the district's Board of Trustees increased our district's Substitute pay and extended the COVID sick leave to its employees. He noted that the omicron surge has waned, and that COVID numbers have drastically declined at this time.

Dr. Alfaro reminded the members of the approval and recommendation and shared that this was brought to the Board of Trustees and will consider the recommendation in a future meeting.
