By signing below, I understand that:

- A. Student enrollment in either the Dual Language Program or Spanish Immersion Program is optional.
- B. Admission into either the Dual Language Program or Spanish Immersion Program is open only to students attending kindergarten at Howard Early Childhood Center.
- C. Both the Dual Language Program and the Spanish Immersion Program require a 5-year parent commitment for grades 1-5.
- D. Applicants are admitted on a first-come, first-served basis. Siblings of students currently enrolled in either the Dual Language Program or Spanish Immersion Preference and siblings of students who have successfully completed all five years of either the Dual Language Program or the Spanish Immersion Program have preference to open slots over other applicants.
- E. If more applications are received than positions are available at the close of the application period for either program, the District will conduct a lottery to determine admissions.
- F. In accordance with Texas law, 50% of the students in each Dual Language Program class will be dominant English speakers and 50% of the students will be native Spanish speakers at the beginning of the program, whenever possible.
- G. The minimum enrollment requirement of Limited English Proficient (LEP) students for each Dual Language Program class under Texas law shall be the lesser of 30% of the students in the class, or all LEP students served at each home campus. Therefore, LEP applicants for the Dual Language Program will be given lottery precedence until the appropriate number of LEP students are admitted.
- H. Students enrolled in either of these Programs are expected to read in English every night at home in order to establish a foundation for English reading and writing skills.
- I. Students enrolled in either of these Programs may experience a lag in acquisition of English reading and writing skills, which will generally continue through the 4th grade.
- J. The maximum Spanish Immersion Program classes' size will be set between 24-26 students. Each Dual Language Program maximum class size is expected to be 22 students.
- K. **The Spanish Immersion and Dual Language Programs are offered at Cambridge and Woodridge Elementary Schools. Applicant parents must be willing to accept an assignment at either campus. Transportation to other than a student's home campus will not be provided by the District.**
