

### Reasons for Approval/Denial/Revocation of Tuition

The following are acceptable reasons for granting approval of a tuition student in accordance with Board Policy [FDA\(LOCAL\)](#).

- Change of Resident (Current resident leaves AHISD attendance zone) if notification is made to the campus principal no later than five business days before moving out of the district
  - Remain at current school until end of current semester
  - Student may apply for continuing enrollment as specified below
  - Pending acquisition of another home (move to be completed within specified time frame) and necessary documentation provided
- Meets criteria for entry:
  - Satisfactory discipline records from home campus (see below for description of “discipline infractions”).
  - Satisfactory academic performance records (see below for description of academic progress as defined by the Superintendent)
  - Documentation of compliance with Compulsory Attendance Law (at least 90% attendance in all classes and no unexcused absences)

### Reasons for Denial

The following are reasons for denial of a tuition student in accordance with Board policy [FDA\(LOCAL\)](#):

- Admission creates adverse conditions for AHISD in terms of space, financial exigency, or personnel or capital outlay requirements;
- Based upon the Superintendent’s authority to determine that certain programs offered by the District are unavailable to tuition students because of limited resources and staff, and the need to prioritize current slots for resident students of the District, the 09 Academy and CONNECTS are not available for tuition students;
- Records of poor academic performance (elementary: passing all classes; secondary: passing all Grade Level classes), poor attendance (less than 90% attendance for the year/semester), and/or disciplinary infractions at home campus (elementary: no more than 3 disciplinary referrals in a school year; secondary: no more than 3 suspensions from school; no more than 3 In school suspensions (ISS) in a school year; no more than 1 discretionary nor more than 1 mandatory placements in a Disciplinary Alternative Education Placement (DAEP), or any expulsion);
- If tuition application is for the purpose of participating in an extra-curricular activity at receiving campus;
- Falsification of information;
- Failure to meet district criteria; or,
- Failure to notify the campus principal at least 5 business days prior to moving out of the district.

### Reasons for Revocation

The following are reasons for revocation of a tuition student in accordance with Board Policy [FDA\(LOCAL\)](#):

- Should circumstances change such that continued admission creates adverse conditions for AHISD in terms of space, financial exigency, or personnel or capital outlay requirements
- Failure to maintain satisfactory academic progress as determined by the Superintendent (elementary: passing all classes; secondary: passing all Grade Level classes) ;
- Repeated failure to abide by the rules specified in the *Discipline Management Plan* and *Student Code of Conduct* elementary: no more than 3 disciplinary referrals in a school year; secondary: no more than 3 suspensions from school; no more than 3 In school suspensions (ISS) in a school year; no more than 1 discretionary nor more than 1 mandatory placements in a Disciplinary Alternative Education Placement (DAEP), or any expulsion);
- Documented poor attendance (less than 90% attendance and losing credit; Elementary: overall; Secondary: by course); or,  
Falsification of information
